## Terms & Conditions of Sale

1. Sealed Offers shall be submitted in the prescribed Tender Form downloaded from website only, accompanied with Two Demand Drafts or Pay Order or Banker's Cheque, One towards the cost of tender form **i.e. non-refundable** and other one towards the Earnest Money Deposit (EMD) both separately.
2. Demand Drafts or Pay Order or Banker's Cheque should be drawn on any Nationalized Bank/Scheduled Bank only, in favor of "**OFFICIAL LIQUIDATOR, HIGH COURT OF KARNATAKA, BENGALURU, payable at Bengaluru**". The return of EMD to the unsuccessful bidder shall carry no interest.
3. The sealed Tender must be superscripted on its front as "Offer in the matter of: **M/s. SHAKAMBARI FASHIONS PVT. LTD., (In Liquidation)**".
4. 5. The motto of sale is on '**AS IS WHERE IS AND WHATEVER THERE IS BASIS**'. The Rule of Caveat Emptor is applicable.
6. The intending buyers shall be allowed for inter-se bidding only upon furnishing the instruments of DD/PO/BC for prescribed EMD.
7. The tender should be accompanied by the required EMD and any tender without EMD or with insufficient EMD or if improperly submitted will be rejected.
