D. Direct opposite parties to refund to the complainants and Other villa buyers with same interest the amount collected by the opposite party in the name of maintenance deposit with 18% interest.

E. Direct opposite parties to pay compensation of INR10,00,000/- to each of the complainants and Other villa buyers with same interest on account Of the maintenance charges for the amenities which the opposite party has forcefully made the complainants pay for inspite of the fact that amenities have not been Provided.

F. Direct opposite parties to pay to each of the complainants and other villa buyers with same interest a sum of INR10,00,000/- each on account Of mental harassment and trauma.

G. Award cost of the complaint to the complainants and Other villa buyers with same interest.
