

**2<sup>nd</sup> CORRIGENDUM TO THE SALE NOTICE DATED 13.03.2023 IN THE MATTER OF M/S. KINGFISHER AIRLINES LIMITED (IN LIQUIDATION) IN COMPANY PETITION NO. 214/2012.**

1. It is clarified by e-NIVIDA, auctioneer that in case of foreign bidders, though the foreign bidder may make the payment in USD, the currency conversion charges from USD to INR equivalent of the EMD will have to be borne by the prospective bidders @ the prevailing USD-INR exchange rate.
2. While making payment of EMD, Indian bidder/s need to pay the INR equivalent of the EMD @ prevailing USD-INR exchange rate on the date of payment.  
Correct and exact EMD amount should be paid to e-NIVIDA to allow the bidder to participate in the e-auction.

to inform the Bureau of Civil Aviation Security, Delhi for arranging Temporary Entry permits.

The representatives nominated by the prospective bidders are required to carry the below mentioned documents in original physically and assemble at the office of Bureau of Civil Aviation Security, Indira Gandhi International Airport, Mahipalpur, New, Northern Access Road, Mahipalpur, Delhi - 110037 (Near Aerocity) on 10<sup>th</sup> April 2023 (by 10:00 hrs IST):
